EXECUTIVE SUMMARY

A major goal and objective for the 2025-2027 SPIL is to continue the reorganization of the SILC in collaboration with the CIL and DSE. An Executive Director for the SILC was selected by a panel composed of SILC and the DCCIL. The first goal of the new SILC Executive Director will be to establish the SILC as an independent legal entity and pursue 501(c) (3) status and work toward financial independence for this newly established entity. Initially, the DSE will pay the Executive Director via a sub-grant. This grant will be issued effective October 1, 2024, for FY 2025. This grant will require an annual evaluation to be conducted by the SILC, and due by July 1 each year.

The SILC will continue to establish public and private partners to ensure the information regarding the independent living's 5 core services for residents are easily accessible. The SILC will also ensure meetings are publicized and open to the public for input. Public forums will be available both virtually and in person, to ensure full inclusion of participants. The District of Columbia Statewide Independent Living Council will continue to lead in obtaining information from hearings, forums, trainings, and presentations regarding needed services that will improve the lives of people with disabilities in the District. The SILC will have reinstated its website and updated links with the DSE, CIL and other District of Columbia public and private community partners ensuring that information about the 5 Core services for residents are readily located.

Scheduling District of Columbia open to the public "Virtual Meetings" will no longer be a challenge as the SILC will obtain virtual meeting platforms, similar to ZOOM and Webex that will help in facilitating meetings.

The District of Columbia Statewide Independent Living Council (DCSILC) took the lead in convening the necessary public hearings, forums, trainings and presentations toward the completion of the 2025-2027 State Plan for Independent Living (SPIL), the completion

process proved to be a valuable learning experience. In compliance with the SPIL's mandatory involvement of District of Columbia Center for Independent Living, Incorporated (DC CIL) and the DC Department on Disability Services (DDS) which is the District of Columbia's Designated State Entity

(DSE) in accordance with the SILC's request the collaboration necessary to prepare the SPIL required each of the entities (SILC, CIL and DSE) to realize their specific responsibilities in synchronizing successful Independent Living (IL) service provision, policy development and advocacy for legislative implementation for and on behalf of individuals with disabilities residing in the District of Columbia and across the nation.

Other major agreement among all the SPIL entities was the importance of promoting outreach; relocating service providers to the community neighborhoods; partnering with public and private stakeholders for expanded service delivery; promote resource availability through shared websites, web links, newsletters. Each entity expressed the urgency of identifying resource availability by brochure distribution, workshops, public forums and community meetings.

1.1 - MISSION

- Mission of the Independent Living Network and the SPIL:

The Mission of the District of Columbia Statewide Independent Council (DC SILC) shall (in accordance with Section 701 of the Rehabilitation Act) promote a philosophy of independent living, including a philosophy of consumer control, peer support, self-help, self-determination, equal access and individual and system advocacy.

DC SILC shall conduct itself in a manner as to maximize leadership, empowerment, independence, and productivity while fostering the integration and full inclusion of all persons with disabilities into mainstream American Society by promoting activities implemented on behalf of all individual with disabilities.

for people with significant disabilities seeking affordable and accessible places to live. Provide resources and assistance to homeless or individuals transitioning from institutions and seeking to be integrated in the community.

Goal #5: Outreach - The SILC, DSE and DCCIL will collaborate to ensure that persons with disabilities are aware of the resources, services and benefits available for them. Establish "educational workshops" to provide public knowledge of available resources for and on behalf of persons with disabilities. Monitor the implementation of planned programming resulting from the Comprehensive Statewide Needs Assessment (CSNA) completed in FY 2024. Ensure that the findings from CSNA continue to address un-served and underserved populations.

Goal #6: Transition - The SILC and CIL will provide meaningful and informative community-based workshops enabling youth with disabilities to be successful in school or training and in preparation for future employment. A wide variety of information such as access to social services, benefits and resources or opportunities for employment are available; but also, the implementation and education to support and campaign to improve transition skill planning and development.

Goal #7: Advocacy - Provide active support for the equal opportunity, self-determination, and self-respect for people living with disabilities ensuring they have the greatest possible degree of independence in the District of Columbia.

Indicator #1.2.1: The Executive Director will identify pro-bono legal assistance to establish the SILC as a legal entity and apply for 501(c)(3) Non-Profit tax status by July 2025.

Other Objective info and/or Activities (optional):

Geographic Scope: Statewide

Objective #1.3: Support and strengthen the agencies' organizational structure to provide an effective IL service delivery system for DC residents with disabilities.

Measurable Indicators:

Indicator #1.3.1: The DSE and DCCIL will work together to develop and distribute client satisfaction surveys.

Indicator #1.3.2: The DSE will identify additional IL service providers, particularly for IL skills training.

Other Objective info and/or Activities (optional):

Geographic Scope: Statewide

Goal #2: Establish SILC Virtual Meeting setup with public access. The DSE has purchased 10 computers to make available for SILC members to participate remotely in meetings.

Objective #2.1: Have regularly scheduled SILC meetings that allow for in-person or virtual attendance

Measurable Indicators:

Indicator #2.1.1: The DSE has purchased equipment to allow SILC members to participate remotely in meetings. In FY 2025, the SILC will include in its resource plan a Zoom subscription to allow all meetings to be conducted remotely.

Geographic Scope: Statewide

Goal #3: Education - The DSE, the SILC, and the CIL will provide collaborative efforts to ensure that persons with disabilities in the District of Columbia are aware of the resources, services and benefits available for them to take next steps in education, training, community involvement and gainful employment among others. Establish "educational workshops" to provide public knowledge of available resources for and on behalf of persons with disabilities. Provide outreach to identify opportunities and resources at various community venues for people with disabilities.

Objective #3.1: The SILC will work with the DCCIL and DSE to provide for an annual Consumer Forum and Youth Summit

Measurable Indicators:

Indicator #3.1.1: The Forum will provide education to youth and adults with disabilities on topics of interest identified by the SILC; and will provide information about IL services available in the community.

Other Objective info and/or Activities (optional):

Geographic Scope: Statewide

Objective #3.2: Support computer literacy for emerging populations with disabilities.

Measurable Indicators:

Indicator #3.2.1: The SILC and DSE will support the DCCIL's ongoing program providing basic computer skills and utilization of various search engines.

Indicator #3.2.2: DCCIL and SILC will develop and distribute a service regarding access to technology and broadband. Technology questionnaire will be provided to DCCIL consumers and others on internet connectivity, devices, assistive technology and utilization.

Indicator #3.2.3: In collaboration with DC Assistive Technology Program and DCSILC, DCCIL will coordinate a community education program on suggested Apps and related demonstrations for the blind and visually impaired.

Objective #5.2: Assist in the development of the 2026 Comprehensive Statewide Needs Assessment.

Measurable Indicators:

Indicator #5.2.1: Engage DCCIL and SILC with identifying participants to complete questionnaires and surveys and participate in focus groups to ensure that the CSNA correctly identifies unserved and underserved communities of people in need of IL services in DC.

Other Objective info and/or Activities (optional):

Geographic Scope: Statewide

Objective #5.3: DCCIL, DCRSA and DCSILC will co-locate in multiple wards throughout the city, specifically NW, NE and SE

Measurable Indicators:

Indicator #5.3.1: Working with our realtor and community partners to establish co-location sites in the aforementioned areas in order to increase DCCIL's presence and outreach to the disability community in the designated areas

Other Objective info and/or Activities (optional):

Geographic Scope: Statewide

Objective #5.4: DCCIL will establish a Consumer Ambassador Program comprised of people with disabilities with a focus on outreach to people with disabilities in their own communities & a view towards educating them for services available to them and how to access these services.

Measurable Indicators:

Indicator #5.4.1: The program is successful when an identified person with a disability connects with services that are provided by DCCIL.

Objective #6.2: Provide independent living skills and advocacy to youth in transition

Measurable Indicators:

Indicator #6.2.1: DCRSA will utilize their existing partnership with DCPS and DCPCS to collaborate with DCCIL and DCSILC to facilitate more effective outreach and increase awareness of services (eg. IL Skills training)

Indicator #6.2.2: DCCIL, collaborating with DCSILC, will provide advocacy training for youth.

Indicator #6.2.3: In collaboration with DCPS and DCPCS, DCCIL will implement the Y.E.S (Youth Empowered to Succeed) Program to students through the special education department.

Other Objective info and/or Activities (optional):

Geographic Scope: Statewide

Objective #6.3: DCCIL, in collaboration with DCSILC and DCRSA, will plan a Youth Summit organized and run by the youth with a purpose of focusing on the issue that are significant to them.

Measurable Indicators:

Indicator #6.3.1: A successful completion of the summit with action items to advance address issues identified as most pressing to youth with disabilities community along with the distribution and return of consumer satisfaction surveys.

Goal #7: Advocacy - Provide active support for the equal opportunity, self-determination, and self-respect for people living with disabilities ensuring they have the greatest possible degree of independence in the District of Columbia.

Objective #7.1: Support the access to assistive technology for people with disabilities in DC

Measurable Indicators:

Indicator #7.1.1: The DSE and SILC Advocacy Committee will identify representatives to participate in the Assistive Technology Advisory Committee at the Assistive Technology Center at University Legal Services.

Indicator #7.1.2:

Other Objective info and/or Activities (optional): Geographic Scope: Statewide

Objective #7.2: DCCIL will provide each consumer with a Consumer Satisfaction Survey's upon completing a goal. The surveys will be submitted in accessible formats contingent upon a consumers' disability.

Measurable Indicators:

Indicator #7.2.1: The objective will be considered successful when at least 60% surveys are distributed surveys are returned.

Other Objective info and/or Activities (optional): Geographic Scope: Statewide

Objective #7.2: Raise awareness about issues related to safety in the community for people with disabilities.

Measurable Indicators:

Indicator #7.2.1: The SILC will raise awareness and advocate for the creation of an outreach and education campaign on maintaining safety in the community, including advocacy regarding bike lanes and their impact on the safety of people with disabilities.

Other Objective info and/or Activities (optional):

Geographic Scope: Statewide

Objective #7.3: The SILC will advocate to the Mayor to ensure that persons with disabilities are considered in all aspects of emergency planning in DC.

Measurable Indicators:

Indicator #7.3.1: The SILC and DCCIL will ensure that they are included in all emergency planning for DC, to ensure the needs of people with disabilities are considered.

Other Objective info and/or Activities (optional):

Geographic Scope: Statewide

Objective #7.4: The SILC will ensure that it elicits public input regarding the development of the SPIL and the provision and quality of IL services in the District.

Measurable Indicators:

Indicator #7.4.1: The SILC, with support from the DSE and CIL, will host at least four public meetings and an annual youth forum and summit.

Other Objective info and/or Activities (optional):

Geographic Scope: Statewide

1.4 - EVALUATION

The SILC will use various means of evaluation of its progress in implementing and the effectiveness of the SPIL. The SILC will schedule public meetings bi-monthly, to ensure that it holds at least four, up to six meetings per year. Each meeting will include as part of the agenda a time for public comment, to hear from community members about their concerns regarding the needs of people with disabilities and their experience with the service network in place to meet those needs.

- -The SILC has established active committees that meet at least monthly, including:
- The Service Needs/Monitoring and Evaluation Committee will be responsible for overseeing the implementation of outreach and education activities under the SPIL.
- The Advocacy Committee will be responsible for overseeing the implementation of advocacy activities under the SPIL.
- The State Plan Committee will be responsible for developing the state plan and overseeing its implementation.
- The Finance committee will be responsible for assisting int he development of and overseeing the implementation of the SILC Resource Plan.

The SILC will work with the DSE to develop the solicitation for the 2026 CSNA, which will evaluate the effectiveness of services the quality-of-service delivery and effectiveness of the collaboration between service providers.

The DSE has external monitors who evaluate the quality of services provided by contract agencies. These monitors visit each agency at least quarterly to ensure compliance with the provisions in the agency's contract. The monitors have developed a monitoring tool that tracks the requirements outlined in the Human Care Agreement with a provider to determine the extent to which the agency is meeting the requirements of these agreements. Based on the results of these reviews, the DSE has a variety of interventions if performance concerns exist, including providing technical assistance to the agency, suspending referrals for services to allow the agency to correct deficiencies or referring to the DDS Office of Contracts and Procurement with a recommendation for formal action to be taken regarding the contract, either suspending or termination for failure to comply.

The DSE and the CIL in collaboration with the SILC will develop and distribute consumer satisfaction surveys to evaluate the effectiveness of information and referral services, effectiveness of outreach campaigns for housing, service availability, and transition services. Consumer surveys are distributed via US mail to individuals after case closure, along with a stamped return envelope. The Quality Assurance Unit collects the results and analyzes them.

1.5.2 - PART II: FINANCIAL PLANNING NARRATIVE

Sources, uses of, and efforts to coordinate funding to be used to accomplish the SPIL Goals and Objectives. Process for grants/contracts, selection of grantees, and distribution of funds to facilitate effective operations and provision of services.

Goal 1 - Promote the Autonomy of the SILC - The SILC has identified an Executive Director. The DSE will utilize Part B funds from the Resource Plan to establish a grant to pay the Executive Director (ED) as a contractor in year one of the plan. The SILC Executive Committee will establish a performance plan and provide an annual review to the DSE, to confirm the ED's progress and continued employment. The DCCIL will provide in-kind support in the form of administrative support to the ED. The resource plan also includes Part B funds for office supplies to support the SILC. The DSE will support the SILC ED to

identify a pro-bono attorney to assist with establishing the SILC as a legal entity and applying for 501(c)(3) tax exempt legal status.

The DSE Quality Assurance and Performance Management Administration will conduct oversight of the provision of IL services provided via human care agreements, contracts, and grants. The grantees are identified in the SPIL. The contract and human care agreement providers are identified through the provider qualification process in the Operations Division at the DSE.

The DCCIL, SILC and DSE will work together to develop consumer satisfaction surveys, which will be sent to clients after completion of IL services. The cost of these mailings will be covered as in- kind support from the DSE.

Goal 2 - Establish SILC virtual meetings and public access - the cost of Zoom licenses will be paid by Part B funds, included in the resource plan. Other costs associated with the virtual meetings, such as interpreters will be provided as in-kind support by the DSE.

Goal 3 - The DSE, SILC and DCCIL will collaborate to provide education to ensure that people with disabilities in DC are aware of resources, services and benefits available to them. The DCCIL, DSE and SILC will jointly host an annual Consumer Forum and Youth Summit. Each party will provide a..." of the funding for this event. The SILC and DSE's share of the costs will be paid utilizing Part B funds and the DCCIL will utilize Part C funds. The DCCIL will provide peer support and education groups utilizing Part C funding.

Goal 4 - Housing - The SILC and DCCIL will provide advocacy and education regarding housing. The SILC will utilize funding included in its resource plan, to the extent the advocacy is done by the SILC ED. The DCCIL will utilize Part C funds.

Goal 5 - Outreach - The DSE and DCCIL will utilize Part B and Part C funds to create new outreach brochures.

In developing the Comprehensive Statewide Needs Assessment, the DSE will utilize Section 101(a)(18) innovation and expansion funds for the IL portion of the cost of the completion of this plan (app. 10%) of the cost will be included in the IL Resource Plan, funded with I&E funds.

Goal 6 - Transition - The DCCIL utilizes Part C funds to provide peer support and education to youth with disabilities.

The annual youth summit, as indicated above, is paid for utilizing Part B and Part C funds.

Goal 7 - Advocacy - The DSE will utilize staff funded through local funds to participate on the AT Advisory Committee; The SILC will have a volunteer also participating on this committee. To the extent necessary Resource Plan funds, from Part B will be available to support this individual volunteer.

The DCCIL and SILC provide advocacy on safety. The DCCIL utilized Part C funds to provide education and technical assistance to the DC Department of Transportation on safety issues, particularly on issues related to bike lanes and their impact on people with disabilities.

The SILC will ensure representation on the DC Homeland Security and Emergency Management Administration's emergency planning council. The SILC participant will receive support through the Resource Plan, to the extent necessary.

As indicated above, the costs of the Annual Consumer Forum and Youth Summit will be paid utilizing Part C and Part B funding.

The Resource plan includes \$1000 in Part B funds for any necessary meeting expenses for the regular SILC meetings.

2.2 - OUTREACH TO UNSERVED AND UNDERSERVED POPULATIONS

The DSE defines underserved as groups that are underrepresented in people served by the agency, based on the triannual CSNA. This assessment utilizes local data from the American Community Survey of the US Census to determine the number of people of various communities in the city. This data is then compared with DSE and CIL data regarding demographics of people receiving services. To the extent that the number served is significantly lower, these are identified as underserved.

Unserved communities would be those that are non-existent within our service population but are present in the community. We then develop an outreach plan to increase awareness within these communities of the availability of IL services.

Our current CSNA will be completed by September 30, 2024. The groups identified in the most recent CSNA as underserved were Latinos and Ethiopians.

The District includes only urban populations.

The outreach includes development of brochures by the DCCIL and DSE. The DSE has an outreach supervisor who attends events in the community throughout the year where these materials are share

2.3 - COORDINATION

Plans for coordination of services and cooperation between programs and organizations that support community life for persons with disabilities.

Coordination of activities between the SILC, the CIL and the DSE will be increased by meeting bimonthly and establishing sub-committees to focus on SPIL goals and objectives. The Mayor's Office of Talent and Appointments (MOTA) established the vetting process to expedite new SILC members as requested by the SILC Executive Board. The SILC requires members who are District of Columbia residents that have the time to devote to accomplishing the goals of the SILC. There is currently a small core of dedicated members who accomplish the primary work of the SPIL. The SILC continuously works with MOTA in order to have new members appointed, once they have been identified.

The SILC will work with the CIL and its Board to redefine strategies, curriculum and communication regarding persons with disabilities and the ever-pressing affordable and accessible housing issues via meetings, brown bag lunch forums, neighborhood community meetings and conferences.

The DC SILC worked with the DSE and the State Rehabilitation Council in the development of the scope of work for the current Comprehensive Statewide Needs Assessment for 2023, although due to a variety of contractual issues, this CSNA will not be completed until the end of FY 2024. The subsequent CSNA will be conducted in 2026. The SILC ensures that the scope of work included identification of local communities with un-served or underserved.

Service provision of independent living services was reviewed.

The DCSILC will work with the SRC to establish a "feedback loop" for the RSA from the community so that RSA is kept abreast of community suggestions and concerns and includes the community members when developing solutions.

The DCSILC and the CIL will advocate for the full inclusion of persons with disabilities in city-wide evacuation emergency planning for the District of Columbia.

With the passing of the Disability Protection Rights Act of 2006, which established the Office of Disability Rights, the SILC and CIL assist in planning and implementation of the Olmstead Act as knowledgeable stakeholders advocating on behalf of DC persons with disabilities to ensure full inclusion in the housing market.

The SILC and CIL will continue to advocate with community residents regarding transportation improvements and compliance with the American with Disabilities Act, Title

VI. SILC and CIL members work with numerous stakeholders such as Metropolitan Washington Council of Governments - Access for all Committee and Transportation Policy Board; The Washington Metropolitan Area Transit Authority (WMATA) - Accessibility Advisory Committee (AAC) and the DC Department of For-Hire-Vehicles. DC Transport same day Para - Transit type transportation by accessible taxi cabs and is contracted through the District of Columbia Government. Providing copayments with persons with disabilities that utilize the services.

Provide information and referral services about DSE, DCSILC and DCCIL and available independent living services to persons with disabilities at community exhibits providing outreach, education and referral services at community events.

Partner with other community agencies and stakeholders to promote additional transition to work and/or independent living activities for youth with disabilities.

The SILC, CIL and the Department on Disability Services (DSE) will continue to work with established partners successfully as follows: DC Housing Authority, DC Housing Finance Agency, DC Housing and Community Development, National Council on Independent Living, DC Share (a DCCIL expansion partner), University Legal Services - Housing and Advocacy Unit, Washington Metropolitan Area Transit Authority, and Council of Governments (Transportation Division), Office of Human Rights - specifically the Language Access Coalition, Office of Latino Affairs, Office of Asian and Pacific Islander Affairs and the DC Board of Elections to promote accessible voting processes to expedite information, referral and advocacy on behalf of person with disabilities.

The SILC has bi-monthly public meetings throughout the year. The DSE has a Quality Assurance and Compliance Unit with monitors on staff, who make scheduled and unscheduled visits to IL service providers to facilitate a positive outcome for clients.

The DSE maintains a cross-referral system with the CIL and One Stop Centers in the District. The Department of Employment Services One Stop Centers (American Jobs Centers) personnel are trained t identify persons with significant disabilities who may benefit from vocational Rehabilitation (VR) or independent living (IL) services.

Satisfaction and assessment surveys are conducted regularly; information gathered from these surveys serves to close any gaps in services that are identified. If disparities are recognized in any of the program areas, subsequent objectives and specific goals are developed, implemented and services provided.

The DSE will actively coordinate with the CIL to alleviate replication of program services to IL, Independent Living Older Blind (ILOB) and VR consumers in the following areas;

- Special Education: The DSE has specialized counseling units that work closely with DC Public Schools and DC Public Charter Schools to provide pre-employment transition services to students with disabilities, and to ensure that students are referred for vocational rehabilitation, independent living and developmental disability support services, as appropriate. The CIL coordinates with DCPS, DCPCS and the DSE to provide peer mentoring to transition aged youth. These services are provided both in schools and at the CIL or the DSE offices.
- Vocational Education: The CIL has developed a computer literacy program for emerging populations with disabilities in the District that emphasizes basic keyboarding skills, understanding of WORD, and the various search engines for research. Referred clients attend sessions free of charge as necessary.
- Developmental Disabilities Services The Developmental Disabilities Administration (DDA) is an
 administration under the Department on Disability Services (DSE) along with the Rehabilitation
 Services Administration. Therefore, interagency consumer referrals for VR and IL services are
 regularly exchanged between the two administrations. In addition, the Department on Disability
 Services (DSE) has a Memorandum of Agreement with the Child and Family Services Agency that
 specifically identifies the process for referral and transition from the foster care to the DDA, IL or
 VR System.
- Public Health: The DSE IL specialist refers IL clients as appropriate, consumers to CIL nutrition classes for people with disabilities.
- Mental Health: The Department of Behavioral Health, DSE have collaborated with the CIL, and have developed a support group for Families with Traumatic Brain Injury (TBI). The DSE is part of the Human Services cluster of agencies, as is the Department of Behavioral Health. The coordination occurs at the Deputy Mayor's level to ensure that necessary coordination of services between human service agencies occurs.
- The DCCIL has developed a number of peer support groups, including: YES Peer Group Cross Disability Peer Group
- AHEAD (A Hispanic Empowerment and Diversity Group) The Anacostia Peer Group TBI Peer Group (ACIL)

- Deaf and Hard of Hearing Peer Group
- Women who are Blind and Visually Impaired Peer Group Men who are Blind and Visually Impaired Peer Group The Men's Cross-Disability Peer Group
- The Women's Cross-Disability Peer Group A Family "Benefits Impact" Peer Group
- EPIC (Empowering-Promoting- Independence-Confidence) Peer Group Advocacy Peer Groups
- The CIL will continue to build partnerships with DCPS, DCPCS and community partners which will include but is not limited to outreach to create awareness about CIL services and integrating the CIL's Youth Peer-Support Groups at DC Public Schools and DC Public Charter Schools.
- Housing: The CIL has organized a peer housing advocacy group to speak to the issues around the lack of affordable and accessible housing in the District.
- Transportation: The DSE coordinates and contracts with the CIL to utilize their transportation services in assisting IL and ILOB consumers on an individual case basis.
- Veterans Services: The CIL and the SILC partner and participate in cross disability community meetings, boards and commissions that promote empowerment, independence, and self- sufficiency through independent living services availability. The DC Office of Veterans Affairs is a new peer group that began through collaboration with the DSE.
- Programs under XVIII of the Social Security Act In providing IL services, a counselor first conducts an assessment and then gathers information from the client regarding types of insurance he or she receives or may be eligible for. The IL counselor considers all federal and state programs that may be used to support the individual (e.g., Medicaid, Medicare) before utilizing Part B IL program funding.

The District of Columbia, DHHS/ACL and DDS recognizes one Center for Independent Living despite other CIL staff located throughout different sectors of the city with and without other service provider stakeholders.

Currently, Mr. Richard A. Simms occupies the one District of Columbia Executive Director position. All other CIL are supervised and paid by him.

However, several years ago the CIL Director had requested that another of its fully staffed locations within the District of Columbia be recognized as a separate independent center as well. However, the then USDE/RSA which provided oversite, responded that that location did not fit the criteria needed to be considered another CIL.

Subsequently, locations that are not physically shared by the one Executive Director are referred to as satellite locations.

The one DC CIL is also a registered 501(c)(3) facility and funding received supports staff and volunteers that carry out the functions of the CIL although they may be co-located at other service provider facilities.

- The Anacostia office staff are currently operating out of the NE Office location.

3.2 - EXPANSION AND ADJUSTMENT OF NETWORK

The DCCIL, in collaboration with the SILC and DSE, established the need to identify an additional office located in NW to serve increasingly unserved and underserved multicultural and other emerging populations with disabilities in that city sector.

The current CSNA continued to identify specific needs to provide more outreach in providing VR and IL services to the Latino population in the District. The Northwest office shared with the Greater Washington Urban League co-supported by the DCCIL Part C funds and 501 C-3 funding. Additional funding from DDS contracts for miscellaneous short-term contracts to provide independent living skills training. The continued existence and support identified in the previous SPIL will only continue if the DCCIL collaborates and plans with the other IL stakeholders like DDS.

DCCIL recognizes underserved and un-served boundaries with West to 16th street, to North of Military Road/Missouri Avenue and East to North Capitol to South of H street.

The concentration of Hispanic, Ethiopians, Caribbean Islanders, Africans who live in part of Ward I and Ward 2, also DCCIL recognizes their presence in North of Riggs Road to West of North Capitol to East of Eastern Avenue; these areas cover Wards 4, 5 and 6.

The DCCIL serves the entire District of Columbia.

The prior SPIL had identified an area of the District, which had a high concentration of Hispanics as an area that was underserved. The finding that this group was underserved continues to be an issue, consistent with the findings in the 2020 CSNA.

Officially the entire District is covered under the two current grants, but the NW sector of the city is underserved.

Part C funding above COLA will be used to maintain all current locations including the NW sector location; the percentage of any additional funds should be allocated proportionately.

Minimum funding level for a Center and formula/plan for distribution of funds to ensure that each Center receives at least the minimum.

The District has only one Center. Given the size of the District this one Center is sufficient to meet the jurisdiction's needs.

Priorities for establishment of new CIL(s).

There is no plan for establishing new CILs. The District has only one Center. Given the size of the District this one Center is sufficient to meet the jurisdiction's needs.

Action/process for distribution of funds relinquished or removed from a Center and/or if a Center closes.

There is only one Center in the District. If this Center's funds were relinquished or removed there would not be another qualified Part C entity to receive those funds.

Plan to build capacity of existing CILs and/or expand statewide reach by establishing branch offices and/or satellites of existing CILs.

Currently DCCIL is located at 2600 12th Street, NE, Washington, DC 20018. Due to circumstances

beyond our control (ownership of the building wanting the space for other purposes), the ACIL (Anacostia Center for Independent Living) office at 840 Chesapeake St, SE, Washington, DC 20032 no longer exists as of March 2024. DCCIL continues to provide dedicated services in that area by co-locating at various organizations throughout Anacostia. Our real estate broker, Ed Flenner of Transwestern, is feverishly looking for a suitable location. It is anticipated that a location will be secured by January 1, 2025.

As we plan for a new location, it should be clear that ACIL has been insufficiently funded since its existence. More specifically, it is understood that funding for Centers for Independent Living is based on population, however certain populations have greater needs than other populations and require more resources to help those communities live independently in their homes and communities. It should be amplified that Wards 7 and 8, which ACIL serves, are predominately Black, poor, underemployed, and undereducated. Therefore, more resources are required for this population and should the level of funding continue to be calculated in the same fashion, it is all but guaranteed that this population will continue to be underserved.

DCCIL continues to do a significant amount of outreach in areas of the District with a high concentration of Hispanics in order to reach this unserved population. To address the ever-increasing need to provide services to the Hispanic community, DCCIL hired an additional bilingual Independent Living Specialist with extensive connections to the Hispanic community.

Plan/formula for distribution of new funds (Part B, Part C, one-time funds, etc.)

If additional funds were available, DCCIL would distribute the funds proportionately to its existing locations (NE and SE) and if the funds were significant enough, increase the capacity of the ACIL site and establish a new satellite in the NW sector of the city to serve the Hispanic and other emerging populations, such as the Ethiopian community.

If the current DCCIL grant were terminated, we would recommend that there be one Main/DCCIL grant to cover the entire District of Columbia and establish other community-partnered locations identified as critical service areas to meet the needs of minorities and other emerging populations with disabilities throughout the District of Columbia.

4.0 - DESIGNATED STATE ENTITY

4.2 - ADMINISTRATION AND STAFFING: DSE ASSURANCES

Administrative and staffing support provided by the DSE.

The DSE does not utilize any portion of the Part B funding for administrative costs. The DSE has no employees currently serving as staff to the SILC.

The IL Program at the DSE is located within the Sensory Unit of the Rehabilitation Services Administration. Although IL services may be provided by any one of the forty-five VR specialists in the DSE, there are staff specifically dedicated to provision of IL and ILOB services, as well as VR services to persons who are blind or visually impaired.

The RSA Sensory Unit Supervisor is responsible for the administrative oversight of the IL program. The unit will have the following employees during the 2025-2027 period of this SPIL: one orientation and mobility specialist, one blind rehabilitation specialist, one IL/ILOB Specialist, two VR Specialists, one rehabilitation assistant, and the unit supervisor.

Additionally, DDS has established a comprehensive Human Care Agreement format that must address the five core IL service components for all community providers with DDS contracts that provide IL services to consumers. External reviews through the SILC and DDS Office of Quality Assurance and Compliance are conducted quarterly on all IL HCA providers to ensure that full compliance and client satisfaction with services being provided is well documented.

Consistent with the 2017 SPIL, the agency provides grants to two providers to provide IL services to people through the IL and ILOB grants. These agencies were identified by the SILC and included through the SPIL development process as two entities that could directly receive referrals, complete assessments, develop plans and provide IL services.

4.3 - STATE-IMPOSED REQUIREMENTS

Fiscal Accountability - The Administration has systems in place and qualified staff that control the disbursement of funds and prepare fiscal reports. Records are available for audits upon request. Eligibility - All individuals with a significant disability in need of independent living services are evaluated and provided services. The DSU currently maintains both electronic and hard copy case records. However, during FY 2014, the DSU will transition to exclusively electronic case records. The Non-Discrimination Act applies, as well as the District's Language Access Act, ensuring availability of services to non-English and Limited English speakers in their native language.

Independent Living Plans - IL Plans are developed with the client utilizing informed choice. The case documentation contains goals, objectives, provider of services and timeframes for completion. The client receives a signed copy of the IL plan, which also contains the client's rights and responsibilities.

Process for soliciting proposals

The DSE pays for services utilizing grants and human care agreements. The process for receiving a human care agreement is that a provider must submit an application indicating an interest in providing services, and then must demonstrate that they are able to meet the required qualifications to provide services. These human care agreements are overseen by an agency contract administrator who ensures that services are provided consistent with the agreement, prior to approving payment for services; and provides an annual assessment of performance. In addition, the DSE Quality Assurance Administration assigns a monitor to visit the provider quarterly to conduct quality assurance monitoring, which includes monitoring of client records, review of consumer satisfaction surveys, and interviews of service recipients.

Beginning in FY 2017, in developing the SPIL, the SILC, DSE and CIL made a determination to allow IL funds to be directly allocated to the DCCIL and a DSE IL provider, the Columbia Lighthouse for the Blind. These entities were selected because of a determination that they had the ability to receive direct referrals for IL services, conduct assessments, develop plans and deliver services.

These grants receive the same oversight from the DSE as the human care agreements, in that the Quality Assurance Administration monitors the provision of services and a contract administrator within the Operations division oversees the grants management, ensuring tracking of service provision,

payment for services provided and annual assessment.

The DSE's Quality Assurance and Performance Management Administration conducts monitoring visits of all IL service providers. These visits occur quarterly. The monitors review records, interview clients served and staff, and review customer satisfaction surveys. The QA staff coordinate with the DSE Operations Division, which assigns a contract administrator to oversee the provision of any services provided via contract or grant. The CA is responsible for approving a provider as qualified to provide services, based on the terms of the grant or human care agreement, and ensures that services are provided consistent with these agreements prior to approving payment for any services. In addition, the CA completes an annual evaluation of each provider, based on their review of the services and coordination with the QA monitors.

Section 5: Statewide Independent Living Council (SILC)

5.1 - ESTABLISHMENT OF SILC

How the SILC is established and SILC autonomy is assured.

The SILC was established via Mayor's Order. Volunteers to serve on the SILC are recruited by the SILC, the DCCIL and the DSE. They are officially appointed to the SILC by Mayor's Office of Talent and Appointments, for terms up to three years. The autonomy of the SILC has been an ongoing issue for a number of years. The SILC has historically functioned as a fully volunteer entity, with a chairperson who receives staff support from the DSE. In order to address the concerns regarding autonomy, the SILC included in its Resource Plan a goal of hiring an executive director and establishing the SILC as a separate legal entity. The Executive Director has been identified. The DSE will begin to pay this person in FY 2025 through a grant. Her performance will be overseen by the Executive Committee of the SILC. Her first requirement will be to identify legal support to establish the SILC as a legal entity and apply for 501(c)(3) tax exempt legal status.

5.2 - SILC RESOURCE PLAN

Resources (including necessary and sufficient funding, staff/administrative support, and in-kind), by

funding source and amount, for SILC to fulfill all duties and authorities.

Funding sources may include "Innovation and Expansion (I&E) funds authorized by 29 U.S.C. 721(a)(18); Independent Living Part B funds; State matching funds; [state allotments of Vocational Rehabilitation funding;] other public funds (such as Social Security reimbursement funds); and private sources."



The first priority of the new SILC Executive Director will be to establish a legal entity into which funds can be transferred from the DSE to support to the resource plan. In the interim, the DSE will continue to pay for these expenses directly, including the costs related to the Executive Director's salary, which will be paid via grant. The SILC will have the following annual expenses:

110,000 SILC Executive Director 500 office expenses

150 NCIL Organizational Dues - Annual

1000 meeting expenses (this includes a stipend to attend SILC meetings, for members who are not employed, this does not apply to virtual meetings)

600 NCIL Conference Virtual Registration (2 members) 1,500 SILC Training

2,000 website maintenance

1500 SILC Congress

\$400 Zoom account

10,000 Consumer Forum and Youth Summit (SILC, CIL, DSE each pays 1/3 of total cost) Process used to develop the Resource Plan.

The Resource Plan was developed by the SILC State Plan Committee. This plan was then approved by the SILC, CIL and DSE. The information was also shared at a community meeting, at which we received no comments or concerns.

Process for disbursement of funds to facilitate effective operations of SILC.

Payments for expenses included in the SILC Resource Plan are paid either through a direct payment, a credit card payment or via grant.

The Executive Director salary will be paid via grant, assuming that the candidate selected is able to receive payments via the District's integrated financial system (DIFS). Once enrolled in DIFS, payments will be made monthly.

Expenditures for purchase of most goods under \$5000 and most services under \$2500 can be paid via credit card. Some expenditures, e.g., food, would require approval from the Office of Contracts and Procurement before the purchase can be made. In those instances, a memo is prepared well in advance, if we know that these goods will be needed and is submitted for approval, so that when the purchase is made, there is not delay.

For other purchases, a direct pay or reimbursement could be made. The request for direct pay or reimbursement would be submitted to operations for processing. The full process takes approximately two weeks,

Justification if more than 30% of the Part B appropriation is to be used for the SILC Resource Plan.

Part B funding for the Resource Plan currently constitutes 33.5% of the total grant. Although this is higher than 30%, we believe this is justified for two reasons. First, we include \$10,000 in SILC Resource Funds allocated to the Community Forum and Youth Summit. While this is included in the Resource Plan, this should also be considered direct service, as this is included as education and outreach in our plan. Subtracting this amount from the resource plan, the percentage would be slightly over 30%, i.e., 30.4%.

In addition, it has been a long-standing goal to establish the SILC as a legal entity and hire an Executive Director. The rate of pay for a position at this level in the District of Columbia is high, even in the Non-Profit sector.

5.3 - MAINTENANCE OF SILC

SILC members are appointed by the Mayor. Within the Mayor's office, the Office of Talent and Appointments (MOTA) has responsibility for making these appointments. The DCCIL, the SILC and the DSE are responsible for identifying and recruiting new members who are then referred to MOTA for appointment.

The SILC is established via Mayor's Order, which outlines the membership requirements for the organization.

The staffing of the SILC includes only an Executive Director. Administrative support is provided by the DCCIL, as an in-kind contribution. The Executive Director was selected through a process including the SILC and the DCCIL. The SILC Executive Committee will be responsible for establishing a performance plan and preparing an evaluation, to be due in July of each calendar year. Based on the results of the evaluation and input from the SILC Executive Committee, the DSE will make payments to the Executive Director. Once the SILC is established as a separate legal entity, this entity will work with the DSE to establish the system for oversight of the SILC ED. Appointments are made in a timely manner to keep the SILC in compliance with the Act

The SILC and the DSE will work closely with the Mayor's Office of Talent and Appointments to ensure timely appointment of new members, once identified by the SILC, CIL or DSE.

The SILC is organized in a way to ensure it is not part of any state agency

The first goal of the new Executive Director of the SILC will be to establish the SILC as a separate legal entity, organized as a 501(c)(3) tax exempt organization.

The SILC has the autonomy necessary to fulfill its duties and authorities, including "[working] with CILs to coordinate services with public and private entities, . . . conducting resource development, and performing such other functions . . . as the [SILC] determines to be appropriate

As indicated above, the SILC will establish a separate legal entity, which will have its own separate legal status, ability to manage its own funds and staff. It will co-locate with the DCCIL and will benefit from in-kind donation of administrative support from the DCCIL.

Necessary and sufficient resources are provided for the SILC Resource Plan to ensure the SILC has the capacity to fulfill its statutory duties and authorities

The SILC Resource Plan includes approximately 30% of the Part B grant funds to carry out the functions of the SILC. In addition, \$20,000 of the local match will be devoted toward Resource Plan funds.
